Based on a desk review of CMS PT records, it was determined the laboratory director, moderate complexity testing, failed to ensure that PT samples were tested as required under subpart H. of this part. The findings included: For the analytes, Glucose and Alcohol, the laboratory repeatedly failed to achieve satisfactory performance for the same analytes or tests in two out of three consecutive testing events, resulting in unsuccessful PT performances.
