This STANDARD is not met as evidenced by: Based on review of the Certification and Survey Provider Enhanced Reporting (CASPER) Report 0155D Individual Laboratory Profile and American Proficiency Institute (API) report, the laboratory failed to achieve satisfactory performance for two of three consecutive events (2025-2 and 2025-3) for the analyte Uric Acid. The finding include: Uric Acid 20% - 2025 second testing event; Uric Acid 40% - 2025 third testing event; A review of the 2025 scores from American Proficiency Institute (API) confirmed the above findings.
