The findings include: 1. For 2025 event 1, the laboratory received an unsatisfactory performance score of 60% for the analyte, pO₂. 2. For 2025 event 2, the laboratory receive an unsatisfactory performance score of 60% for the analyte, pO₂. 3. The CASPER 155 report and graded results from API confirm the findings listed above.</p>
