This STANDARD is not met as evidenced by:

Based on surveyor desk review of the laboratory proficiency testing (PT) records (graded copies from the American Proficiency Institute and CASPER reports 0153D /0155D from the Centers for Medicare and Medicaid Services data system) on 11/17 /2022, the laboratory has not successfully performed proficiency testing for Sodium in two of two testing events. Findings include: A review of the laboratory records from the American Proficiency Institute (API) and the CMS CASPER reports 0153D /0155D revealed the laboratory scored the following for Sodium: : Year 2022 - 2nd Event: 20% Year 2022 - 3rd Event: 60%
