D0000	Based on a proficiency testing (PT) desk review survey performed on August 19, 2024, the laboratory was found to be out of compliance based on the following CONDITION LEVEL DEFICIENCIES: D2016 - 42 C.F.R. 493.803 Condition: Successful participation. D6000 - 42 C.F.R. 493.1403 Condition: Laboratory Director, moderate complexity.
D2016	SUCCESSFUL PARTICIPATION CFR(s): 493.803(a)(b)(c) (a) Each laboratory performing nonwaived testing must successfully participate in a proficiency testing program approved by CMS, if applicable, as described in subpart I of this part for each specialty, subspecialty, and analyte or test in which the laboratory is certified under CLIA. (b) Except as specified in paragraph (c) of this section, if a laboratory fails to participate successfully in proficiency testing for a given specialty, subspecialty, analyte or test, as defined in this section, or fails to take remedial action when an individual fails gynecologic cytology, CMS imposes sanctions, as specified in subpart R of this part. 	the laboratory failed to successfully participate in the CMS approved PT program for four of four consecutive testing events in the Endocrinology subspecialty for the Free TY (Thyroxine) and TSH (Thyroid Stimulating Hormone) test analytes in 2023 and 2024, resulting in non-initial unsuccessful performance. This STANDARD is not met as evidenced by: Based on CMS PT CASPER 0155D and MLE PT summary reports from 2023 and 2024, the laboratory failed to achieve satisfactory performance (80% or greater) for four of four consecutive testing events in the Endocrinology subspecialty for the Free TY and TSH test analytes. FINDINGS: 1. A review of the CASPER 155 report revealed the following unsatisfactory scores: Endocrinology Subspecialty: 2023 First Event = 40% 2023 Second Event = 20% 2023 Third Event = 0% 2024 Second Event = 0% Free TY Test Analyte: 2023 First Event = 20% 2023 Second Event = 0% 2023 Third Event = 0% 2024 Second Event = 0% TSH Test Analyte: 2023 First Event = 60% 2023 Second Event = 40% 2023 Third Event = 0% 2024 Second Event = 0% 2. A review of the proficiency testing scores from MLE (2023 and 2024) confirmed the above findings.
