D0000	Based on a Proficiency Testing (PT) desk review survey performed on August 20, 2026, the laboratory was found to be out of compliance based on the following CONDITION LEVEL DEFICIENCIES: D2016 - 42 C.F.R. 493.803 Condition: Successful participation. D6000 - 42 C.F.R. 493.1403 Condition: Laboratory Director, moderate complexity.
D2016	SUCCESSFUL PARTICIPATION CFR(s): 493.803(a)(b)(c) (a) Each laboratory performing nonwaived testing must successfully participate in a proficiency testing program approved by CMS, if applicable, as described in subpart I of this part for each specialty, subspecialty, and analyte or test in which the laboratory is certified under CLIA. (b) Except as specified in paragraph (c) of this section, if a laboratory fails to participate successfully in proficiency testing for a given specialty, subspecialty, analyte or test, as defined in this section, or fails to take remedial action when an individual fails gynecologic cytology, CMS imposes sanctions, as specified in subpart R of this part. 	successfully participate in the CMS approved PT program for two out of three consecutive testing events in the Endocrinology subspecialty for the Thyroid Stimulating Hormone (TSH) test analyte in 2025 and 2026 resulting in unsuccessful performance. Refer to D2107.
D2107	ENDOCRINOLOGY CFR(s): 493.843(f) (f) Failure to achieve satisfactory performance for the same analyte or test in two consecutive testing events or two out of three consecutive testing events is unsuccessful performance. This STANDARD is not met as evidenced by: Based on CMS PT CASPER 0155D and API summary reports from 2025 and 2026, the laboratory failed to achieve satisfactory performance (80% or greater) for two out of three consecutive testing events in the Endocrinology subspecialty for the analyte TSH. FINDINGS: a. A review of the CASPER 155 report revealed the following unsatisfactory scores: 1. TSH Test Analyte: 2025 Third Event = 40% 2026 Second Event = 60% b. A review of the PT scores from API (2025 and 2026) confirmed the above test event findings.
