Findings include: 1. On the day of survey 11/14/2023 at 11:26 am, review of CAP PT records revealed the laboratory received a score of 90% for ABO/RHO typing for the CAP PT 2023 J-A Event . 2. GS #3 confirmed the above finding on 11/15/2023 at 3:45 pm</p>

On the days of survey, 11/14/2023 and 11/15/2023, the laboratory could not provide site specific documentation of the annual competency assessment for 1 of 3 GS (CMS-209 personnel #2) for their supervisory responsibilities in 2023. 3. Findings include: 1. On the days of survey, 11/14/2023 and 11/15/2023, the laboratory could not provide documentation of the twice annual verification of accuracy for DAT and Wet Prep microscopic examinations performed from 09/14/2021 through the days of survey. 2. The laboratory reported an annual volume of 711 immunohematology examinations and 258 Microbiology examinations (CMS-116). 3. GS #3 confirmed the findings above on 11/15/2023 at 3:45 pm</p>

 Based on review of the laboratory's procedures, operator manuals, and interview with general supervisor #4 (GS), the laboratory failed to have a complete written procedure manual for chemistry testing performed that met the requirements of 493.1251 from 09/14/2021 to the date of the survey. Findings include: 1. On the day of the survey, 11/14/2023 at 03:55 pm, review of the procedure manuals for chemistry testing revealed the operators manuals were used to perform testing on the Beckman Coulter AU680 chemistry analyzer from 09/15/2021 to 11/14/2023: 2. Review of the operators manual revealed that the test system instructions used failed to include the following requirements of 493.1251: - Step by step performance of the procedure including test calculations and interpretation of results - Preparation of slides, solution, calibrators, controls, reagents, stains, and other material used in testing. - Control procedures - Calibration and calibration verification procedures. - Corrective action to take when calibrations or control results fail to meet the laboratory criteria for acceptability. - Limitations in the test methodology, including interfering substances. -The reportable range for test results for the test system as established or verified in 493.1253. - Reference intervals (normal values). - Imminently life-threatening test results, or panic or alert values. - The laboratory 's system for entering results in the patient record and reporting patient results including, when appropriate, the protocol for reporting imminently life threatening results, or panic, or alert values. - Description of the course of action to take if a test system becomes inoperable. 3. GS #4 confirmed the findings on 11/15/2023 at 03:45 pm.

Findings include: 1.The laboratory procedure manual in use for hematology reviewed at the time of inspection on 11/14/2023 at 05:14 pm, revealed the procedures were not approved, signed and dated by the current LD. 2. The laboratory's annual volume for Hematology is 89,669 (CMS-116). 3. GS #3 confirmed the above findings on 11/15/2023 around 3:45 pm.

This STANDARD is not met as evidenced by:
Based on observation of the laboratory, lack of documentation, and interview with General Supervisor (GS) #3, the laboratory failed to monitor and document room temperatures to ensure operating conditions were met for the proper storage of reagents from 09/14/2021 to the day of survey. Findings Include: 1. On the day of survey, 11/15/2023 at 2:30 pm., during the laboratory tour and interview with GS #3, the surveyor discovered the room temperature was not monitored in the storage area where supplemental Beckman Coulter DXH analyzer diluent was stored. 2. The manufacturer's instructions states, " Store at 2 to 40C , as directed on the product label. To maintain product quality, store according to the instructions in the product labeling." 3. The laboratory could not provide documentation of the storage room temperatures taken where supplemental Beckman Coulter DxH diluent was stored from 09/14/2021 to 11/15/2023. 4. GS #3 confirmed the findings above on 11/15/2023 around 3:45 pm.

Based on lack of documentation and interview with the General Supervisor (GS) #3, the laboratory failed to document a positive and negative control each day of patient testing for Trichomonas wet mount microscopic examinations performed from 09/14 /2021 to the day of survey. Findings include: 1. The laboratory's Trichomonas Wet Prep/Urine procedure states "Quality control will be performed with each specimen by reviewing the Urinalysis/Parasitology Microscopic QC Manual. Once this manual has been reviewed and signed off, testing can be performed." 2. On the day of survey 11 /14/2023 at 05:14 pm, the laboratory could not provide documentation of the positive and negative control performed every day of patient testing from 09/14/2021 to 11/15 /2023. 3. The laboratory reported a total volume of 8 tests performed in 2022 (CMS- 116 annual volume). 4. GS #3 confirmed the above findings on 11/15/2023 at 3:45 pm.

On the days of survey, 11/14/2023 and 11/15/2023, the laboratory failed to provide documentation of the biannual comparison studies performed in 2022 and 2023 for the following: - Automated white blood cell (WBC) differential performed on the Beckman Coulter DxH 600 analyzer versus manual WBC differential - Human chorionic gonadotropin (hCG) testing performed on the Beckman Coulter Access II analyzer (quantitative) versus Cardinal hCG Combo Rapid Test: Serum (qualitative) 2. GS #3 confirmed the findings above on 11/15/2023 at 3:45 pm.

Based on review of quality assurance (QA) records, and interview with general supervisor (GS) #3, the Laboratory Director (LD) failed to ensure a QA program was maintained and documented to ensure the quality of services provided by the laboratory from 09/14/2021 to the dates of survey. Findings include: 1. The laboratory's Quality Assessment: Laboratory policy states, "Each month records will be reviewed by the Laboratory Manager and a "Quality Assessment Review" form will be completed. Records, when appropriate, will be forwarded to the Laboratory Director for final review and signature. The completed "Quality Assurance Review" form will be returned to the Laboratory Manager for storage." 2. On the days of survey, 11/14/2023 and 11/15/2023, the laboratory could not provide documentation for the periodic QA evaluation performed to assess the laboratory's pre-analytical, analytical, and post-analytical processes from 09/14/2021 to 08/30/2023. 3. GS #3 confirmed the findings above on 11/15/2023 around 3:45 pm.

Based on review of personnel qualification records, proficiency testing (PT) records, quality control (QC) records, and interview with General Supervisor #3 (GS), the laboratory failed to ensure that 2 of 2 laboratory personnel met the requirements under C.F.R 493.1447 to perform technical supervision for immunohematology testing performed from 09/14/2021 to the day of the survey. Findings include: 1. On the date of the survey, 11/14/2023 at 11:42 am, review of personnel qualification records revealed that 2 of 2 laboratory personnel (CMS 209 personnel # 2 and #3) did not meet the required training/experience requirements (493.1449) to perform technical supervision for immunohematology testing from 09/14/2021 to 11/15/2023. 2. Further review of College of American Pathologists (CAP) PT and QC records revealed laboratory personnel #2 and #3 reviewed the following: - 6 of 6 CAP PT results forms were reviewed by laboratory personnel #3 (2022: J-A, J-B, J-C; 2023: J-A, J-B, J-C) - 3 of 6 CAP PT attestation statements signed by laboratory personnel #3 as designee (2023; J-A, J-B, J-C) - 1 of 6 CAP PT attestation statements signed by laboratory personnel #2 as designee (2022:J-B) - October 2023 Immunohematology QC records were reviewed by laboratory personnel #2 3. Based on review of the Laboratory Personnel Report (CLIA) (Form CMS-209), personnel qualification records (credentials), and interview with General Supervisor #2 (GS), the laboratory failed to ensure that 2 of 8 testing personnel (TP) performing High Complexity testing have the minimum qualifications required from 09/14/2021 to 11/14/2023. Findings Include: 1. On the day of survey, 11/14/2023 at 09:35 a.m., interview with GS #2 and review of credentials for high complexity testing personnel listed on Form CMS-209, revealed the laboratory could not provide documentation of educational credentials for the following testing personnel: - TP #3 (CMS-209 personnel #5) - TP #6 (CMS-209 personnel #8) 2. GS #2 confirmed the findings on 11/15/2023 at 3:45 pm.
