<b>D5215</b>	<p>EVALUATION OF PROFICIENCY TESTING PERFORMANCE CFR(s): 493.1236(b)(2)</p> <p>The laboratory must verify the accuracy of any analyte, specialty or subspecialty assigned a proficiency testing score that does not reflect laboratory test performance (that is, when the proficiency testing program does not obtain the agreement required for scoring as specified in subpart I of this part, or the laboratory receives a zero score for nonparticipation, or late return or results).</p> <p>This STANDARD is not met as evidenced by: Based on review of the laboratory's American Proficiency Institute (API) proficiency testing (PT) records, and interview with Technical Supervisor #1 (CMS 209 #1) the laboratory failed to verify the accuracy of the PT results obtained for 2 of 3 API PT testing events reviewed in 2023. Findings include: 1. The API PT Performance Evaluation stated the following, "Laboratories should review the Performance Summary and Comparative Evaluation thoroughly for failures or 'not graded' analytes. Laboratories are responsible for documenting and performing corrective action for failures and must perform a self-evaluation using statistics presented in the Participant Data Summary for samples that have not been graded." 2. On the day of survey, 08/22 /2024, review of the laboratory's API PT records revealed that the laboratory failed to verify the accuracy for the following analytes that were not scored by the PT agency in 2023: - 2023 3rd Event Immunology/Immunochemistry - Blood Bank Compatibility Ser-12 - 2023 1st Event Microbiology - MIC Value, UR-01, MIC testing/CLSI/Ceftazidime, UR-01 3. TS #1 confirmed the findings above on 08/22 /2024 at 03:00 pm.</p>

storage of reagents and specimens, accurate and reliable test system operation, and test result reporting. The criteria must be consistent with the manufacturer's instructions, if provided. These conditions must be monitored and documented and, if applicable, include the following: (1) Water quality. (2) Temperature. (3) Humidity. (4) Protection of equipment and instruments from fluctuations and interruptions in electrical current that adversely affect patient test results and test reports.

This STANDARD is not met as evidenced by:  
Based on lack of documentation and interview with technical supervisor (TS) #1 (CMS 209 personnel #8), the laboratory failed to monitor and document room temperature and humidity to ensure operating conditions were met for urinalysis testing performed from January 2024 to the date of survey. Findings include: 1. Review of the Clinitek Novus manufacturer's instructions revealed the following technical specifications for ambient operating temperatures: - Room temperature: 15-30 degrees celsius - Humidity: 20 to 80% relative humidity 2. On the day of the survey, 08/22/2024, the laboratory failed to provide documentation of the monitoring of room temperature and humidity to ensure operating conditions were met when performing urinalysis testing on the Clinitek Novus analyzer from January 2024 to the day of the survey. 3. TS #1 confirmed the above findings on 8/22/2024 at 10:00 am.

This STANDARD is not met as evidenced by:  
Based on observation of the laboratory, record review, and interview with Technical Supervisor (TS) #1 (CMS 209 personnel #8), the laboratory failed to perform and document maintenance/function checks as defined by the manufacturer to ensure the proper maintenance of equipment used in the laboratory in 2023 and 2024. Findings include: 1. On the day of survey, 08/22/2024, the laboratory failed to provide documentation of the following equipment maintenance/function checks for equipment used in the laboratory in 2023 and 2024: - Calibration of 1 of 1 NIST Thermometer used to check the accuracy of in use thermometers. - Accuracy checks for 4 of 4 timers used in the laboratory. - Calibration of 4 of 4 pipettes due in 2023 and 2 of 4 pipettes due 2024. - Washing of glassware after cleaning to ensure proper removal of detergent for 18 of 18 months from Jan 2023 to 8/22/2024. 2. TS #1 confirmed the above findings on 8/22/2024 at 2:30 pm.

 Based on review of quality control (QC) records, Becton Dickinson media manufacturer's instructions, and interview with Technical Supervisor #1 (CMS 209 #1) the laboratory failed to document the visual checks performed on each batch of media for contamination or deterioration from 10/06/2023 to 12/21/2023. Findings include: 1. The Becton Dickinson media manufacturer's instructions stated the following: - Quality control requirements must be performed in accordance with applicable local, state and/or federal regulations. -Prior to use, each blood culture vial should be examined for evidence of damage, contamination or deterioration. Vials displaying evidence of damage or contamination such as leakage, cloudiness, discoloration (darkening), bulging or depressed septum should not be used. - Do not use plates if they show evidence of microbial contamination, discoloration, drying, cracking or other signs of deterioration. - Do not use tubes if they show evidence of microbial contamination, discoloration, drying or other signs of deterioration. 2. On the day of survey, 8/22/2024, review of the microbiology quality control (QC) logs revealed the laboratory failed to document the visual checks performed on each batch of media for contamination or deterioration for the following media used from 10/06/2023 to 12/21/2023: -BD BACTEC Standard/10 Aerobic/F Culture Vials:12/21/2023. -BD BACTEC Standard/10 Anaerobic/F Culture Vials:12/21/2023. -BBL Chocolate II Agar: 10/10/2023. -BBL MacConkey II Agar:10/10/2023. -BBL Fluid Thioglycollate Medium: 10/06/2023. -BBL Trypticase Soy agar with 5% Sheep Blood (TSA II): 10/10/2023. 3. TS #1 confirmed the findings above on 8/22/2024 at 11:43 AM.

This STANDARD is not met as evidenced by:  
 Based on review of quality control (QC) records, and interview with Technical Supervisor #1 (CMS 209 #1) the laboratory failed to document and maintain quality control records for gram stain testing performed from 07/26/2023 to 02/15/2024. Findings include: 1. The laboratory's Gram Stain procedure stated, "smears of organisms of known gram stain reactions should be run along with the patient." 2. On the day of survey, 8/22/2024, review of the laboratory's gram stain QC records revealed the laboratory failed to document and maintain QC records for gram stain testing performed with each patient from 07/26/2023 to 2/15/2024. 3. The laboratory performed 14 gram stains from 07/26/2023 to 02/15/2024. 4. TS #1 confirmed the findings above on 08/22/2024 at 03:00 pm.

This STANDARD is not met as evidenced by:  
 Based on review of the laboratory's Quality Assurance (QA) policy, record review, and interview with Technical Supervisor (TS) #1 (CMS 209 personnel #8), the laboratory failed to follow established written policies to monitor the analytic systems in chemistry and hematology from 12/23/2022 to the day of survey. Findings include: 1. The laboratory's QA Policy stated, "Instrument daily, weekly, and monthly maintenance is performed and documented as required by the manufacturer. All maintenance, temperature charts, calibrations, calibration verifications and other department checks are reviewed monthly by the Laboratory Manager (LM) or designee," This policy was adopted 12/23/2022. 2. On the day of survey, 08/22/2024, review of maintenance records for the Sysmex Novus/UF 5000 analyzer revealed no documentation of maintenance performed for 4 of 159 days since put into use in January of 2024 to the date of the survey. 3. Further review of maintenance, quality control and temperature records revealed no documented monthly review of the following by the LM or designee: - Temperature logs for the Chemistry and Hematology departments for 11 of 18 months from 1/1/2023 to 8/22/2024. - Maintenance logs for the Sysmex Novus/UF 5000 analyzer for 5 of 5 months from March 2024 until 8/22/2024. - Quality Control for the Sysmex Novus/UF 5000 analyzer for 5 of 5 months from March 2024 to 8/22/2024. 4. TS #1 confirmed the above findings on 8/22/2024 at 11:30 am.

Findings include: 1. The laboratory's Interface and Manual Result Integrity policy stated, "at least 2 examples of reports from at least 4 disciplines are required every 2 years if not previously obtained". This policy was adopted 6/1/2023. 2. On the day of survey, 08/22/2024, the laboratory failed to provide documentation to verify the integrity of its interfaced and manually entered results as per policy. 3. TS #1 confirmed the above findings on 8/22/2024 at 2:30 pm.

(j) If the requirements of paragraph (b) of this section are not met and the laboratory performs tests in the specialty of hematology, the individual functioning as the technical supervisor must-- (j)(1)(i) Be a doctor of medicine or a doctor of osteopathy licensed to practice medicine or osteopathy in the State in which the laboratory is located; and (j)(1)(ii) Be certified in clinical pathology by the American Board of Pathology or the American Osteopathic Board of Pathology or possess qualifications that are equivalent to those required for such certification; or (j)(2)(i) Be a doctor of medicine, doctor of osteopathy, or doctor of podiatric medicine licensed to practice medicine, osteopathy, or podiatry in the State in which the laboratory is located; and (j)(2)(ii) Have at least one year of laboratory training or experience, or both, in high complexity testing for the specialty of hematology (for example, physicians certified either in hematology or hematology and medical oncology by the American Board of Internal Medicine); or (j)(3)(i) Have an earned doctoral degree in a chemical, physical, biological or clinical laboratory science from an accredited institution; and (j)(3)(ii) Have at least 1 year of laboratory training or experience, or both, in high complexity testing within the specialty of hematology; or (j)(4)(i) Have earned a master's degree in a chemical, physical, biological or clinical laboratory science or medical technology from an accredited institution; and (j)(4)(ii) Have at least 2 years of laboratory training or experience, or both, in high complexity testing for the specialty of hematology; or (j)(5)(i) Have earned a bachelor's degree in a chemical, physical or biological science or medical technology from an accredited institution; and (j)(5)(ii) Have at least 4 years

For example, an individual, who has a doctoral degree in chemistry and additionally has documentation of 1 year of laboratory experience working concurrently in high complexity testing in the specialties of microbiology and chemistry and 6 months of that work experience included high complexity testing in bacteriology, mycology, and mycobacteriology, would qualify as the technical supervisor for the specialty of chemistry and the subspecialties of bacteriology, mycology, and mycobacteriology.

This STANDARD is not met as evidenced by:

Based on review of personnel qualification records, quality control (QC) records, and interview with technical supervisor #1 (TS) (CMS 209 TS #1), the laboratory failed to ensure that 1 of 2 TS met the requirements to perform technical supervision for immunohematology testing from 12/07/2022 to the day of survey. Findings include: 1. On the day of survey, 8/22/2024 review of the laboratory's immunohematology QC records revealed that TS #1 reviewed all QC documents for Immunohematology from 12/07/2022 to the day of survey. 2. Further review of personnel qualification records revealed TS # 1 did not meet the required education requirements to perform technical supervision of testing performed in immunohematology under 493.1449. 3. TS #1 confirmed the findings above on 8/22/2024 at 2:15 pm. .
