Review of the Casper Report 0155D and PRPTSP scores on June 21, 2026, confirmed that the laboratory had a PT (Proficiency Test) failure for the analyte Hemoglobin (HGB) tests in the specialty of hematology. The laboratory obtained the following testing scores: Analyte: Hemoglobin (HGB) a. Second testing event year 2025 - 40% b. First testing event year 2026 - 0% 2. A review of the PRPTSP records confirmed the above findings.
