The findings include: 1. Review of the Casper Report 0155D and PRPTSP scores on January 26, 2026, confirmed that the laboratory had a PT (Proficiency Test) failure for the analyte pCO₂ (Arterial blood gases) tests in the subspecialty of routine chemistry. The laboratory obtained the following testing scores: Analyte: pCO₂ (Arterial blood gases) a. First testing event year 2025 - 60% b. Third testing event year 2025 - 40% 2. A review of the PRPTSP records confirmed the above findings.</p>
