The findings include: 1. Review of the Casper Report 0155D and PRPTSP scores on February 11, 2026, confirmed that the laboratory had a PT (Proficiency Test) failure for the analyte Hematocrit (HCT) tests in the specialty of hematology. The laboratory obtained the following testing scores: Analyte: Hematocrit (HCT) a. First testing event year 2025 - 60% b. Third testing event year 2025 - 20% 2. A review of the PRPTSP records confirmed the above findings.</p>
