The findings include: 1. Review of the Casper Report 0155D and PRPTSP scores on Febrero 2, 2026, confirmed that the laboratory had a PT (Proficiency Test) failure for the Glycohemoglobin (HA1c) analyte tests in the subspecialty of routine chemistry. The laboratory obtained the following testing scores: Analyte: Glycohemoglobin (HA1c) a. First testing event year 2025 - 60% b. Third testing event year 2025 - 0% 2. A review of the PRPTSP records confirmed the above findings.</p>
