This STANDARD is not met as evidenced by: Review of personnel Records and interview of facility personnel found that the laboratory director failed to ensure that one of two testing personnel had documented training prior to performing high complexity testing of patient specimens for Histopathology. D6168	TESTING PERSONNEL CFR(s): 493.1487 The laboratory has a sufficient number of individuals who meet the qualification requirements of 493.1489 of this subpart to perform the functions specified in 493. 1495 of this subpart for the volume and complexity of testing performed. This CONDITION is not met as evidenced by: Based on a review of the Laboratory Personnel Report, policies and procedures, personnel records, competency assessments and staff interview, it was revealed that

one of two testing personnel performing high complexity testing (grossing) did not have the appropriate documented training required to perform high complexity testing. (refer to D6171).

This STANDARD is not met as evidenced by:

Based on review of the CMS report 209 laboratory personnel report, personnel records and interview of facility personnel found that one of one testing personnel performing gross analysis of patient tissue specimens failed to have documented training. NOTE: THIS IS A REPEAT DEFICIENCY FROM THE 2018 INSPECTION The findings included: 1. Review the CMS report 209 laboratory personnel report found two testing personnel listed for high complexity testing. 2. Review of personnel files found that testing person two who performed the gross examinations of histopathology had no documentation of training for the inking, scoring and dissection of tissue specimens. 3. During interview of testing person two on the CMS report 209 Laboratory Personnel Report conducted on August 6, 2024 at 1:22 PM confirmed that she started performing gross analysis of tissue specimens in September 2023 and that there was no documentation of training available for review.
